Tax-Fiscal Division Contests resolved from Jan – Dec 2015

Fiscal Division – is a division established by Kosovo Judicial Council in compliance with the Law on Courts and the same operates within the Department for administrative Issues of Basic Court of Prishtina.

Fiscal division, in 2015, has resolved **341** cases, i.e. dealing with tax.

The average for resolving one case of **FISCAL-TAX DIVISION CONTESTS** was **639 days**, so for one case.

The way of resolving 341 cases was:

- 222 cases based on the main review, out of which:
 - o 110 cases, with Approval of statement of claim;
 - 9 cases with partial approval of statement of claim;
 - o 103 cases, with refusal of statement of claim.

The average for resolving of cases **BASED ON THE MAIN REVIEW** was **649 days**, so for one case:

• 66 cases with dismissing the lawsuit.

The average of resolving the3 cases **WITH DISMISSING THE LAWSUIT** was **605 days**, so for one case;

• 25 cases; By withdrawing the lawsuit.

The average for resolving the cases **BY WITHDRAWING THE LAWSUIT** was **649 days**, so for one case;

• 15 cases, suspended the proceedings

The average for resolving the cases **BY WITHDRAWING THE LAWSUIT** was **617 days**, so for one case;

• 13 cases, Resolved in another way;

The average for resolving the cases **RESOLVED IN ANOTHER WAY** was **647 days**, so for one case.

<u>Civil executions – mortgages resolved Jan – Dec 2015</u>

Civil executions – Mortgages, the courts in 2015, resolved 79 cases i.e. dealing with tax.

The average for resolving one case of *Civil execution – Mortgages* was **1296** *days,* so for one case.

The way of resolving 79 cases was:

• 48 cases, Withdrawn (of the bailiff)

The average for resolving the cases **Withdrawn (of the bailiff)** was **1184 days**, so for one case.

• 30 cases, Closed

The average for resolving the cases *Closed* was **1520** days, so for one case.

Bankruptcy cases - resolved from Jan - Dec 2015

Commercial department in B.C. of Prishtina, in the field of bankruptcy, in 2015, resolved 1 case.

With respect
